NCN enjoyed another fantastic year of growth both in our organization and in the companies we support. In 2015, we were involved in several notable financings including the first ever outside investment for Emma, a leading email marketing company. Groups360 also raised money through NCN,

launching their technology solution for hotel group meetings

during the last year. Also, several of our companies including NextGxDx, Aspire Health, and CloudBeds raised meaningful

NCN recently analyzed a dataset provided by LaunchTN about funding activity in the state of Tennessee. While statewide venture capital investments have increased over the last five years, so has the gap between seed funding and institutional funding. NCN plays an important role in addressing this capital gap. In Nashville, 12 different companies raised more than \$3 million last year. 42% of those financings

involved NCN. Over the last 5 years, nearly all of the NCN companies that have gone on to raise \$3 million or more had previously raised \$1-3 million

from NCN. This data illustrates just how important it is to have a consistent source of professional capital that can bridge companies from the seed stage


